

BY-LAW # A-102

A BY-LAW RELATING TO THE REPEAL OF BY-LAWS OF THE CITY OF MONCTON

(Consolidated to include amendments A-102.1, A-102.2, A-102.3; A-102.4; A-102.5 and A-102.6)

BE IT ENACTED by the Council of the City of Moncton under the authority vested in it by the Municipalities Act, R.S.N.B. 1973, c. M-22, as follows:

1. All By-laws (and all amendments thereto) listed in Schedule "A" hereto and forming part of this by-law are hereby repealed.
2. The repeal of any by-law listed in Schedule "A" hereto shall not in any way affect or void any agreements entered into thereunder.

A by-law entitled "A BY-LAW RELATING TO THE REPEAL OF BY-LAWS OF THE CITY OF MONCTON", being by-law # A-1, ordained and passed on December 18, 1995, and all amendments thereto, is hereby repealed.
