## 6.1 PUBLIC PRESENTATIONS

5 minutes

6.1.1 **Presentation:** House of Nazareth update, Amanda Canning, Case Manager

Ms. Canning provided a presentation to City Council on the services offered at House of Nazareth and detailed the challenges they have experiences and shared success stories and updated housing data from their shelter.

House of Nazareth is a housing focused shelter that strives to ensure Moncton's homeless population can access services, actively removing barriers to services, collaborating with community organizations, while providing support and encouragement as they work towards their housing goals and ensuring they have the proper support.

Their Facility were happy to share that they have housed and diverted over 100 individuals since July 2022. This month, they have housed and diverted 8 individuals so far. Individuals begin the process towards housing as soon as they walk into the facility.

## 6.2 ADMINISTRATION PRESENTATIONS

6.2.1 **Update** – **RCMP** – Superintendent Benoit Jolette, Officer-in-Charge (OIC) of the Codiac Regional RCMP

Superintendent Jolette provided a few highlights of RCMP activities:

## **Community Policing Unit**

- Continue to work with partners and increase visibility in the community.
- Deployment of officers on bicycles with a focus on St George Street and Main Street.
- The team continues to look for areas of concern that they can patrol.

## Crime Reduction Unit/ Integrated Enforcement Drug unit

- This unit intercepted a stolen vehicle and seized a good quantity of drugs
- Performed a search warrant on High Steet and seized a variety of drugs and four people were charged in relation to this seizure.
- Officer recently spotted a stolen vehicle connected to a crime spree on PEI. Officers were able to arrest the driver and place charges.

## Open air drug enforcement / Education & Street Enforcement Unit

- Officers in this unit try to educate and point those suffering with addition towards services such as Ensemble that can help them.
- Eleven interactions were made in the effort to stop open air drug use. These interactions included various seizures, warrants of arrests, and 3 stolen vehicles recovered.

## **General Investigations Unit**

- Recently officers were called to residence to stop an active sexual assault on a child. The male appeared in court and was charged.
- Two men and 1 woman were arrested in connection with an investigation on exploitation targeting youth/ sextortion. These people were new to Moncton and were creating a network targeting young adults and were subsequently charged and ended the network they were creating.
- This month, 14 search warrants have been executed.
- Intake files from this month include robbery, child luring, sexual assaults.
- 4 individuals were arrested in connection to an Identity theft/Fraud on customers of a local car dealership.

# 7. PLANNING MATTERS

7.1 **Introduction** – Rezoning at 620 McLaughlin Drive (Francophone School Complex) – Josh Adams

Mr. Adams provided a PowerPoint presentation to Council on a rezoning application received from the Department of Education and Early Childhood Development to rezone the Francophone School complex and daycare located at 620 McLaughlin Drive (PID 70645676). The application is to rezone the property from R2 (Two Unit Dwelling Zone) to P-1 (Community Use Zone) to accommodate École Le Mascaret, École Claudette-Bradshaw, and a daycare.

**Motion: That** Moncton City Council proceed with the rezoning process of By-Law Z-222.12 to rezone 620 McLaughlin Drive (PID 70645676) from R2 (Two Unit Dwelling Zone) to P-1 (Community Use Zone) to permit a public school and daycare, and:

- a. That Council give first reading of By-Law Z-222.12;
- b. That the By-Law be referred to the Planning Advisory Committee for their written views, with an extension until April 26, 2023 to receive those views;
- c. That a Public Hearing be set for May 15, 2023; and

The rezoning, if approved, should be subject to the following terms and conditions including but not limited to:

- a) That a 10-metre-wide easement be granted to the City of Moncton for a future trail;
- b) That the development shall be carried out in substantial conformance with the plans and drawings submitted as Schedule B;
- c) That the fencing on the northern property line as shown in Schedule B be installed in 2023;
- d) That all uses of land pursuant to this resolution shall conform to the provisions of the City of Moncton Zoning By-Law, as amended from time to time, except as otherwise provided herein; and
- e) That nothing contained herein shall prohibit or in any way limit the Developer's right to apply for a variance pursuant to the provisions of the Community Planning Act.

7.2 **Public Hearing** – Zoning and Municipal Plan Amendment for Local Governance Reform – Josh Adams

The purpose of this report is to accommodate amendments to the Zoning By-Law and Municipal Plan to account for the lands that were annexed to the City of Moncton on January 1, 2023.

The amendments are described in Draft Zoning By-Law Z-222.11 and Draft Municipal Plan By-Law Z-122.3.

A background report detailing the changes and relevant supporting documents are attached to this report.

The provincial government initiated the Local Governance Reform initiative in 2021, which led to a restructuring of many communities across the province. The reforms have reduced the number of local entities in the province from 340 to 89.

As a result of this initiative, the City of Moncton's municipal boundary was changed as a portion of the former Moncton Local Service District was annexed to the City. The annexed lands are approximately 10 square kilometers in size, located in the northwest portion of the City.

Deputy Mayor Butler opened the Public Hearing and the City Clerk read a written objection received from the National Farmers Union in New Brunswick into the record.

Deputy Mayor Butler asked if any other objectors wished to speak.

Mr. Louis Bergeron, a resident of Lutes Mountain requested to speak. He advised that a petition was created against the amalgamation of Lutes Mountain into Moncton. He disagreed that adequate consultation was conducted with the general public.

The Acting City Manager responded that Mr. Bergeron's concerns were not directly related to this Public Hearing, but, that future discussions and consultations could be conducted with the Province as they imposed these changes on the City. This Public Hearing relates to preserving the rights of the newly added areas.

Ms. Suzanne Fournier of the National Farmer's Union of NB added that adequate consultation was not conducted with the senior members of the Department of Agriculture or their group. Although current agricultural production will not be impacted by these proposed regulations, future farms will be impacted.

Mr. Adams advised that their department is provided with a list of who to contact on rezoning and municipal plan amendments, this individual expressed no concern with the changes proposed. He added that he does not believe the standards they are proposing are significant enough to be an issue as other avenues are available to make changes such as variances.

Mr. Mackay reiterated the concerns expressed by the National Farmers Union of NB over the zoning changes that will impact agricultural production in Moncton.

Mr. Adams advised that their department had not contacted the Department of Agriculture, but, acknowledged that more consultation could have been conducted with groups such as the National Farmers Union NB. However, the scope of the amendment does not include consultations. He

advised there will be a time in the near future to have these conversations as more work needs to be done to municipal and zoning By-Laws regarding food security.

Deputy Mayor Butler closed the public hearing.

**Motion: That** Moncton City Council to proceed with the proposed Zoning By-Law and Municipal Plan amendments, being By-Laws Z-122.3 and Z-222.11.

Administration further recommends that Moncton City Council give second and third readings to proposed By-Laws Z-122.3 and Z-222.11.

## STATEMENTS BY MEMBERS OF COUNCIL
