6.1 PUBLIC PRESENTATIONS

6.

6.1.1 **Presentation** – Update from Downtown Churches – Rev. Chris Vanbuskirk and Pastor Richard Jackson

Father Chris Vanbuskirk, Saint George's Anglican Church and Pastor Richard Jackson of First Baptist Church addressed City Council on behalf of Downtown Churches to provide an update on their current activities with regards to the needs of the people in their neighborhood.

Representatives from St. Bernard' Church, Highfield Baptist, First Baptist, Central United, St. John's United, and St. George's Anglican have been meeting to discuss how to provide consistent strategies in meeting and ministering to those who attend for worship and those camping on their properties.

Their staff have received de-escalation training from the RCMP and sharing ideas for boundarysetting and security.

Outreach programs have continued through the winter and the churches remain in close contact with the YMCA Reconnect Street Intervention team.

The Winter Shelters have provided relief to the church's breakfast and shower program. Socialization in safe places is vital and an afternoon drop-in location is required.

The church has no immediate intention to ban people from their programs and properties, but institutional support is often needed for those dealing with addictions.

Mayor Arnold thanked both Rev. VanBuskirk and Pastor Jackson for their presentation and their hard work in helping vulnerable populations in the community.

6.1.2 **Presentation** – Update from EnviroPlus – Jean-Claude Cormier, President

Mr. Cormier requested a presentation at this City Council meeting to remind the public that their organization Enviroplus recycles used furniture, therefore he urged residents not to throw out furniture that could be repurposed such as desks, mattresses, and couches. Furniture can be picked up directly from homes and can be scheduled by calling their office.

He added that currently Atelier Second Chance has successfully matched 4 people with work and thanked the City of Moncton for their support.

Other Presentation

2 minutes

Sophie Despres registered to speak for 2 minutes on homelessness but withdrew her request.

Suzanne Trites, a representative of the International Christian Embassy Jerusalem took the opportunity to address Council to extend the invitation to the Yom HaShoah 2023, a Community Remembrance of the Holocaust on Sunday, April 23 at 2 p.m.

The Guest Speaker is Gally Felter Gonen and she will tell the story of the Jewish community in Sibiu (Hermannstadt), Transylvania, Romania, who lived through times of persecution and hostility with resilience and courage.

6.2 ADMINISTRATION PRESENTATIONS

15 minutes

6.2.1 **Update** – **RCMP** – Superintendent (Supt.) Benoit Jolette, Officer-in-Charge (OIC) of the Codiac Regional RCMP

Supt. Benoit Jolette provided a few highlights on the work by the Codiac Regional RCMP:

Crime Reduction Unit

This unit has had a lot of success with search warrants and locating drugs. Two recent seizures were made on Mill Road and Salisbury Road. A large quantity of Crystal Meth, Cocaine and MDMA and weapons were found.

Open air drug enforcement - Education and Street enforcement

- A total of disruptions
- 21 people checked
- 3 drug seizures
- 6 drug paraphernalia seizures
- 22 syringes found
- 9 Warrants of arrest have been executed.

Supt Jolette added that he believes more addiction services are needed with this this problem

General Investigations Section

Since the last Council Meeting, there have been 15 new files opened:

- 5 are related to sexual offenses and all are victims under 16
- 3 are child abuse investigations
- 3 violent offenses, 2 shooting and 1 stabbing

Within the last two weeks, 15 of the ongoing files have been closed.

Patrols

On April 12, the RCMP received the report of a female going to several financial institutions trying to open several fraudulent financial accounts. She was located, arrested, and put into custody.

Another individual that was a "travelling criminal" was found to be forging prescriptions at local pharmacies and was also located and arrested in connection to this crime.

The RCMP has successfully located thieves that were stripping wire and stealing mass quantities of copper. These individuals were arrested and sentenced.

6.2.2 **Presentation** – Update on Codiac Transpo fare changes for those under the age of 12

This item has been postponed to the meeting of May 1st, 2023.

6.2.3 **Presentation** – Update on Environmental Initiatives, Climate Action Report – Tim Moerman, Director of Director of Environmental Planning and Management

Mr. Moerman provided an update on progress made through the City's climate mitigation initiatives from the 2020 Climate Action Report. Half of the initiatives are completed or ongoing. Mr. Moerman also highlighted some of the activities scheduled for Earth Day 2023 including the Stepping Lightly Booth at the Moncton Market and Earth Day cleanup.

6.2.4 **Presentation –** Rising Tide update – Dale Hicks

Mr. Hicks provided a presentation to Council with an update on the progress made by Rising Tides. He summarized the funding their group has received from various levels of government and provided an overview of the phasing of their developments. Most of these developments are currently underway or completed.

Rising Tide acknowledged the funding received from the City of Moncton which includes \$6M of capital contribution. City officials are working with Rising Tide on land purchases to ensure land acquisitions will meet zoning and bylaw provisions. Site plans, designs and renderings are reviewed with the intent of accelerating approval processes. Mr. Hicks reiterated that these efforts are truly appreciated and demonstrate how the City is a true partner in their efforts to create affordable housing.

Councillor Bourgeois took a moment to speak on health issues he has faced within the last six months. He apologized to the citizens if he may have been absent or if he missed any calls/emails as some may have fallen through the cracks. He also took a moment to thank those who have reached out during these difficult times and thanked the medical professionals from the George Dumont Hospital and the Saint John Hospital, and the Dr. Léon Richard Oncology Centre for their professionalism and their care.

Mayor requested that the wording in the last paragraph of the recommendation be adjusted to "That Council direct administration to dedicate <u>at least one</u> Community Officer resource per shift... and asked if the movers and seconders would agree to alter the recommendation.

The Mayor wanted to highlight the actions the City has taken on the social issues we are facing including:

- Investing more money in social agencies in Moncton
- Supporting and providing funding to Rising Tides for housing
- Providing a location and funding for the out of the cold shelter
- Increase funding for the By-Law Enforcement department
- Doubled the number of Community Safety Officers who work 24/7
- Increase budget for the Social Inclusion Plan which includes money spent to deal with vandalism, theft and tent site cleanup.
- The CRPA has increased their number of RCMP officers from 139 to 170 members and increasing their budget by 15%
- Staff, Council and social agencies are spending a lot of time and resources on this file and there has been ongoing discussions with the Province.

Mayor Arnold concluded by thanking Council for all their work and stepping up in a significant way on this file.

Motion: That, due to delays outside of the contractor's control which prevented this contract from being completed in 2022, Moncton City Council approve the revised Tender price submitted by J.K.
