Other Presentation

Presentation: Active Transportation – Calvin Martini, Active Transportation Coalition

On behalf of the Active Transportation Coalition, Mr. Martini spoke on the St. George Street Redevelopment and respectfully requested that City Council postpone the decision to approve the St George Street redevelopment and Corridor Review tonight.

Presentation: Suzanne Trites – Jewish Community

Ms. Trites provided a verbal presentation on her concerns with the recent decisions related to the cancellation of the menorah lighting and urged City Council to reverse this decision.

Presentation: Irwin Lampert – Jewish Community

Mr. Lampert provided a verbal presentation on behalf of the Jewish Synagogue in Moncton, He provided a brief history of the Jewish Community in Moncton, their contributions to life in City and spoke on their disappointment with the recent decisions related to the cancellation of the menorah lighting. He urged City Council to reverse this decision. The community believes reinstating the lighting of the menorah, a long-standing tradition in Moncton, it will send a strong message of solidarity with the Jewish Community during these difficult times. In conclusion, Mr. Lampert invited all members of Council and the Public to the ceremony to light the menorah in front of City Hall on Thursday, December 7, 2023 at 5:45 p.m.

Presentation: Shawn Annis – Pastor of Christian fellowship – Relocation of Menorah and Nativity Scene

Pastor Annis spoke on the recent issue to remove the religious symbols in front of City Hall and believes the decision was insensitive and that decisions such as these should not be made in closed sessions of Council.

Pastor Annis added that although he supports the pro-Palestinian right to protest in front of City Hall, the decisions to ban the menorah is discriminatory and sends the wrong message at this difficult time.

12.16 Religious Symbols on Municipal Facilities

As per Council's direction, item 12.16 was brought forward on the agenda.

Motion: That Moncton City Council approve the display of religious symbols on city of Moncton properties. That they immediately display back to their location in front of City Hall. This includes displaying at City Hall, the Menorah, a symbol of the Jewish holiday of Hanukkah, and also includes the manger scene, a symbol of the Christian faith during the December holiday season of Christmas.

6.2 ADMINISTRATION PRESENTATIONS

6.2.1 **Update** – **RCMP** – Superintendent Benoit Jolette, Officer in Charge (OIC) of the Codiac Regional RCMP

Supt. Benoit Jolette provided an update on RCMP activities.

Community Policing

- The New Community Policing Unit office on Main Street is now open.
- Members of the RCMP participated in the Santa Claus Parade on November 25
- On December 6th the Community Policing team will be recognized by the Crime Prevention Association of NB.

Crime Reduction Unit

• On November 23, members found a known young offender in possession of a stolen vehicle. The vehicle was recovered and returned to the owner.

General investigations

• In recent weeks, an investigation of a serious kidnapping file was done in Moncton. Patrol teams responded to a report of a home invasion and kidnapping involving a firearm. A female victim was taken into a vehicle and thrown from the vehicle resulting in many injuries. On November 29, a search warrant was executed in the Scoudouc area in connection with this file. Five people were located, as well as firearms seized and several serious charges are pending.

7. PLANNING MATTERS

7.1 **Introduction** – Rezoning of five PIDs at the north end of McLaughlin south of TransCanada (Master Plan) – Bill Budd

Mr. Budd provided a presentation to City Council on an application received from ATMJ Properties Ltd. to rezone lands located on the north end of McLaughlin Drive, just south of the Trans-Canada Highway, bearing PIDs 00777748, 00790014, 70177845, 70263314, 70573134, and 70629753 from R2 (Two Unit Dwelling Zone) to RM (Residential Mix Zone), R3 (Multiple Unit Dwelling Zone) and P1 (Community Use Zone).

The rezoning will accommodate the development of a master planned area with a mix of medium to high density residential development. The project will include 512 new units, in a mix of buildings that will be between 1.5, 2, 4, and 6 storeys in height.

Motion: That Moncton City Council proceed with the Zoning By-law amendment being By-law Z-222.20; and

- 1. That Council give 1st reading to Zoning By-law amendment By-law # Z-222.20;
- 2. That a public hearing be set for January 15, 2024;
- 3. That By-law # Z-222.20 be referred to the Planning Advisory Committee for its written views; and

The rezoning, if approved, should be subject to a resolution with conditions including but not limited to:

- 1. That notwithstanding section 129(1) of the Zoning By-law, buildings A, B, and C are permitted to be taller than 4 storeys (15 metres) provided the buildings are set back a minimum of 15 metres from any abutting land zoned R2 (Two Unit Dwelling);
- 2. That options for the City to acquire the triangular-shaped remnant parcel required for the TransCanada Highway interchange be explored, and the land be acquired if it is deemed to be in the best interest of the City.
- 3. That all uses of land pursuant to this resolution shall conform with the provisions of the City of Moncton Zoning By-law, as amended from time to time;
- 4. That nothing contained herein shall prohibit or in any way limit the Developer's right to apply for a variance pursuant to the provisions of the Community Planning Act; and
- 5. The development shall be carried out in general conformance with the plans and drawings submitted as Schedule B.

In response to Councillor Richard, Mr. Budd indicated he is not aware of any units within the development being designated as affordable housing units. He made note and address it in Council Report Form for the Public Hearing

7.2 **Introduction** – Rezoning PID 01100726 off Whitfield Trites (Winery)

Mr. Budd provided a presentation on an application received from Trace Planning and Design, on behalf of the landowner of 30 Whitfield Trites Road and bearing PID 1100726, to amend the Municipal Plan and rezone the property. The application proposes to redesignate the property from NH (Neighbourhood Quarter) and RR (Rural Residential) to MHT (Magnetic Hill Tourism) and rezoning the land from R2 (Two Unit Dwelling) and RR-1 (Rural Residential) to TR (Tourism and Recreation).

The rezoning will allow retail and entertainment uses at the Pioneer Estates Winery. This will include hosting visitors for indoor and outdoor wine tastings, wine sales, and hosting larger events such as weddings and corporate rentals. The development will include a new outdoor patio and terrace, a parking area, and a temporary overflow parking section.

Motion: That Moncton City Council proceed with the Municipal Plan amendment Z-122.4 and Zoning By-Law amendment By-Law Z-222.13 and

- 1. That Council give 1st reading to the Municipal Plan amendment By-Law Z-122.4 and Zoning By-Law amendment By-Law Z-222.13;
- 2. That a public presentation be set for December 18, 2023;
- 3. That a public hearing be tentatively set for February 5, 2024; and
- 4. That By-Laws Z-122.4 and Z-222.13 be referred to the Planning Advisory Committee for its written views; and

The municipal plan amendment and rezoning, if approved, should be subject to a resolution with conditions including but not limited to:

- 1. That all uses of land pursuant to this agreement shall conform with the provisions of the City of Moncton Zoning By-Law, as amended from time to time.
- 2. The grass on the temporary parking area must be cut regularly.
- 3. That nothing contained herein shall prohibit or in any way limit the Developer's right to apply for a variance pursuant to the provisions of the Community Planning Act.
- 4. The development shall be carried out in substantial conformance with the plans and drawings submitted as Schedule B.

In response to Councillor Steeves' question in regards for clarification on the Noise By-Law requirements, Mr. Budd indicated that will bring forth a response at the Public Hearing.

7.3 **Introduction** – Rezoning – Rockaway subdivision off Salisbury Road (Master Plan) – Bill Budd

Mr. Budd provided a presentation on an application received from Wayne Coster, landowner, to rezone lands located on the north side of the Salisbury Road between Llangollen Road and Carmel Street. The lands were subdivided and registered back in the 1950s, which created the "Rockaway Subdivision". Almost all the lands within the subdivision were acquired by Mr. Coster (with the exception of one property), who now wants to rezone the property from R2 (Two Unit Dwelling) to RM (Residential Mix) and proceed with a revised development plan. The rezoning will accommodate a variety of housing styles. In total, the development will include 150 new dwelling units, consisting of townhouses, semi-detached housing and single unit dwellings.

Motion: That Moncton City Council proceed with the Zoning By-Law amendment being By-Law Z-222.21 and

- 1. That Council give 1st reading to Zoning By-Law amendment By-Law # Z-222.21;
- 2. That a public hearing be set for January 15, 2024; and
- 3. That By-Law Z-222.21 be referred to the Planning Advisory Committee for its written views; and

The rezoning, if approved, should be subject to a resolution with conditions including but not limited to:

- 1. That all uses of land pursuant to this agreement shall conform with the provisions of the City of Moncton Zoning By-Law, as amended from time to time, except as otherwise provided herein:
- 2. Notwithstanding the Zoning By-Law requirements, the minimum lot frontage for a future semi-detached dwelling on lot 23-07 will be 10.06 metres;
- 3. Phase I shall include the construction of the emergency access shown on the plan.
- 4. The design of the emergency access is subject to the acceptance of the City of Moncton Engineering Department and City of Moncton Fire Department and shall be finished with a gravel base.
- 5. Prior to the commencement of Phase III, the emergency access shall be paved, unless another access if provided to an adjacent subdivision by a public street;

- 6. That nothing contained herein shall prohibit or in any way limit the Developer's right to apply for a variance pursuant to the provisions of the Community Planning Act; and
- 7. The development shall be carried out in substantial conformance with the plans and drawings submitted as Schedule B.

The aim of the amendment is to support the creation of housing units in the non-profit sector. To support the proposed amendment new Policy of Council is proposed as part of the proposed Zoning By-Law amendment.

Mr. Smith provided a presentation on the initiative to change all residential uses in the Municipal Plan and ZoningBy-Law from conditional (i.e. subject to terms and conditions by the Planning Advisory Committee) to permitted (as-of-right development).

This initiative will improve Design Standards by increased predictability and flexibility in By-Law, reduce the need for variance, address neighbourhood compatibility and NIMBYism, variance mechanism allows added conditions (maintain a degree of tailoring).

Motion: That Moncton City Council proceed with the amendment process to change all residential uses in the Municipal Plan and Zoning By-Law from conditional to permitted, and that the Public Hearing be confirmed for 4:00pm at City Hall on January 15, 2024.

7.6 **Public Hearing** – Zoning By-Law Amendment – Integrated Development Zones – Bill Budd

Mr. Budd provided a presentation outlining the amendment to allow Integrated Development (ID) zones to be established by an agreement or resolution when adopted by City Council.

The Mayor opened the public hearing and confirmed that there were no objections to this amendment or anyone in attendance to speak on the matter then closed the Public Hearing.

No participant wished to address council, the Mayor closed the public hearing.

7.7 **Public Hearing** – Rezoning at Moncton East Business Park – Bill Budd

Mr. Budd provided a presentation detailing the request for Moncton Industrial Development Ltd. (MID) proposing to rezone a portion of the Moncton East Business Park (Business Park) from HC (Highway Commercial) to ID (Integrated Development).

The amendment is intended to analyze the existing regulatory environment in the Business Park and to provide a broader range of commercial uses than is currently permitted in the Highway Commercial zone. The proposed zoning (ID – Integrated Development) is site specific and will apply to the Business Park lands only.

Additionally, the amendment aims to rezone three properties owned by the City of Moncton (City) from HC to P2 (Open Space and Conservation). This is meant to acknowledge the subject properties as important open spaces to be preserved for conservation purposes.

The Mayor opened the public hearing and confirmed that there were no objections on the matter then closed the Public Hearing.

No participants wished to address Council, the Mayor closed the public hearing.

Motion: That Moncton City Council proceed with the Zoning By-Law amendment, being By-Law Z-222.17, by giving second and third readings of the By-Law.

The Zoning By-Law amendment, if approved, shall be subject to terms and conditions of a Moncton City Council resolution, the draft of which is included as Schedule B to this Council Report dated December 4, 2023.

- 6. Implement intersection improvements at various intersections including some turning lanes reducing pedestrian crossing widths and optimizing traffic signal timing.
- Reduce on-street parking on St. George Street in consultation with business and property owners.
- 8. Review options for additional on-street parking on side streets; and

Proceed with business consultation and the review of on-street parking utilization on side streets.

Moved by: Councillor LeBlanc Seconded by: Councillor Léger

Councillor Steeves asked if Mr. Calvin Martini could provide some of the highlights from his previous 2-minute presentation on this item.

Mr. Martini summarized his presentation and advised that the Active Transportation Coalition have concerns with the study on the St. George Street redevelopment being a high traffic focused corridor. The group would like to see consultation for this area to be a more functional pedestrian

focused corridor. Additionally, the Active Transportation Coalition would like to be involved in choosing the consultant that will conduct the evaluation for this corridor.

Councillor Léger requested that this item be postponed until a new consultant is hired.

Motion: That the recommendation from the Committee of the Whole of November 27, 2023 relating to the St. George Street Reconstruction Project be postponed in order for administration to hire a new consultant for the St. George Street Corridor Review within the next 6 months.
