1. Purpose Statement

Moncton City Council

The main purpose of the *HAF Growth Areas Housing Grant Program* is to incentivize, by way of grants, the development of new housing in <u>Development Charge Areas</u> over the <u>CMHC</u>, <u>HAF</u> funding period (2023 – 2026). The *HAF Growth Areas Housing Grant Program* includes a per-door incentive grant for landowners and developers in <u>Development Charge Areas</u> to be disbursed upon the successful completion of the building's foundation.

2. Application

This Policy applies to landowners and developers seeking to construct new residential <u>dwelling units</u> within Development Charge Areas.

3. Definitions

Building Inspector: means 'Building Inspector' as defined in the City of Moncton Building By-law # Z-422 or successor by-law.

Building permit: means a 'permit' issued pursuant to the *Building Code Administration Act, S.N.B.* 2020, c. 8, or any amendment thereto.

CMHC: means the Canada Mortgage and Housing Corporation.

Development: means 'development' as defined in the Community Planning Act, SNB 2017, c. 19.

Development Charge Area: means a property located within an approved Development Charge Area, as identified in the City of Moncton Development Charge By-Law #Z-1519 or successor by-law.

HAF: means the <u>CMHC</u> Housing Accelerator Fund.

The following terms are defined in the City of Moncton Zoning By-Law # Z-222 or successor by-law, and have the same meaning in this Policy:

Dwelling
Dwelling unit
Multiple unit dwelling
Rowhouse dwelling
Semi-detached dwelling
Single unit dwelling
Three unit dwelling
Townhouse dwelling

4. Policy

Administration

(1) The Director of Planning and Development, or designate thereof, is responsible for administering this Policy.

Eligibility, Application and Review Process

- (2) The subject property or properties must be located within a Development Charge Area.
- (3) Any applicant wishing to be considered for a grant under this policy must complete and submit an Application Form (see Appendix A) to the City of Moncton following the issuance of a building permit.
- (4) This grant is only eligible to <u>developments</u> that have applied for a <u>building permit</u> after the signing of the contribution agreement between <u>CMHC</u> and the City of Moncton.
- (5) Only one application may be made per property and applications will be processed in order of receipt.

Grant Amounts and Disbursements

- (6) Grants will be disbursed in order of successfully completed Application and approval by the application review committee, which shall include the:
 - a. Director of Planning and Development or designate thereof;
 - b. Director of Economic Development or designate thereof; and
 - c. Controller / Deputy Treasurer or designate thereof.

- (7) Prior to approval and disbursement (note: the Director of Planning and Development is the signing authority of the application review committee), the building foundation shall be deemed complete by either:
 - a. Confirmation by the **Building Inspector**; or
 - b. The submission of a report by the applicant prepared by the project architect that certifies the building's foundation is complete.
- (8) Upon approval of the Application, the following grant amounts will be disbursed:
 - a. \$5,000 for a single unit dwelling;
 - b. \$10,000 per <u>dwelling unit</u> for a <u>two unit dwelling</u>, <u>semi-detached dwelling</u>, <u>three unit</u> dwelling, townhouse dwelling, or rowhouse dwelling; and
 - c. \$15,000 per <u>dwelling unit</u> for a <u>multiple unit dwelling</u>.
- (9) A total of 10 <u>dwelling units</u> may be approved per application, the total amount of which shall not exceed \$150,000.
- (10) Grant funding is dependent on federal funding from the <u>HAF</u>. Despite the approval of an Application, scheduled disbursements may be cancelled at the discretion of the Director of Planning and Development, or designate thereof, where there is indication that <u>HAF</u> funding is depleted or will be revoked.
- (11) Although applicants may submit more than one Application, the consideration and potential approval of subsequent Applications will be contingent upon any funds remaining at the latter part of the <u>HAF</u> funding period.
- (12) Where the property for which an Application has been submitted is found to be in violation or contravention to any City of Moncton by-law or is subject to any outstanding work orders or any other enforcement procedures of the City of Moncton or any other governmental authority, the application may be refused or pending grant disbursements may be cancelled.

Expiry of Program

(13) This Policy and *HAF Growth Areas Housing Grant Program* shall expire upon the disbursement of all budgeted HAF funds.
